



## MEMORANDUM OF UNDERSTANDING

Between

**University of Rajasthan**

and

**Nidhi Designs**

This Memorandum of Understanding (MoU) is made on January 16, 2024 between University of Rajasthan, located at JLN Marg, Jaipur (hereinafter referred to as "UoR"), and Nidhi Designs (hereinafter referred to as "Nidhi Design"), located at 267, Shanti Nagar, Gopalpura Bye Pass, Jaipur. This MoU aims to formalize the collaboration between the two parties in the areas of research, student development, and industry-academic partnership in the garment and textile sector.

### Objectives

The purpose of this MoU is to establish a mutually beneficial partnership between University of Rajasthan and Nidhi Designs, a Garment Export Company to achieve the following objectives:

- Joint research projects focused on innovation in textile technology and sustainable practices
- Enhancing industry-academic collaboration through guest lectures, seminars, and workshops
- Developing academic curriculum aligned with industry needs in fashion, textile, and export management

### Areas of Collaboration

The parties agree to collaborate in the following areas:

- Research and Development: Joint research projects on advanced garment manufacturing techniques, sustainability, and innovations in textile materials.

### **Roles and Responsibilities**

University of Rajasthan will:

- Facilitate the development of academic programs aligned with industry trends.
- Organize joint workshops, conferences, and seminars for industry engagement.

Nidhi Designs will:

- Offer internships, training, and hands-on experience to students.
- Provide access to industry data, resources, and facilities for research purposes.
- Contribute expertise for curriculum development and academic activities.
- Engage in joint research efforts to explore new technologies, sustainability practices, and market trends.

### **Funding and Resources**

This MoU does not entail any direct financial commitments unless specified in separate agreements. Specific projects and activities will be developed with clear financial arrangements as needed.

### **Confidentiality**

Both parties agree to keep any confidential information shared in the course of this collaboration strictly confidential unless otherwise agreed upon in writing.

### **Intellectual Property**

Any intellectual property (IP) resulting from joint research efforts will be subject to mutual agreement between the parties. A separate IP agreement will be made if necessary.

### **Duration and Termination**

This MoU is effective from the date of signature and will remain in effect for a period of three years. It may be renewed, extended, or amended by mutual consent. Either party may terminate this MoU by providing 6 weeks written notice to the other party.
